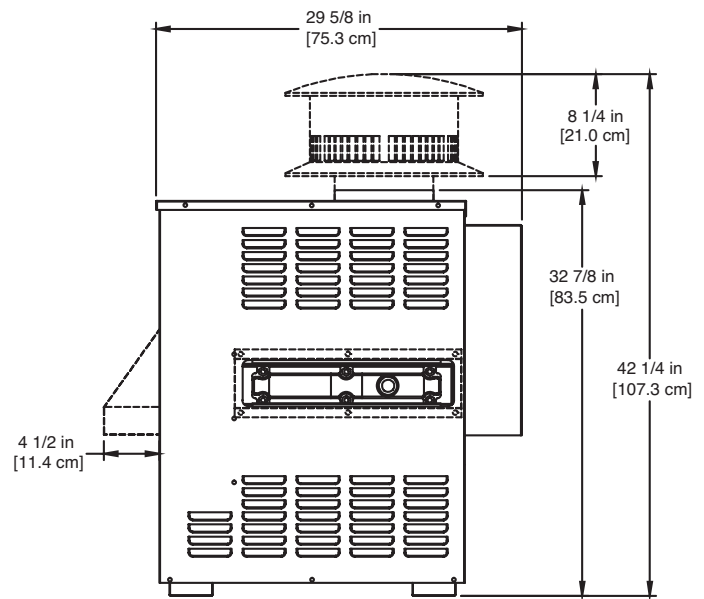
TOP
